Gold Coast H.O.G. Chapter 9056 – Club POLICY



Gold Coast H.O.G. club members must understand that the personal and professional identities intersect on Social Media web sites. Club Members personal lives and activities will undoubtedly contribute to their reputation and may (correctly or incorrectly) be attributed to the Gold Coast H.O.G. club.

Club Members should never assume any Social Media communication will remain private, irrespective of their privacy settings.

The following is a non-exhaustive list of prohibited conduct in relation to Social Media. This behaviour may be considered inappropriate by the Gold Coast H.O.G. and constitute grounds for exclusion from the club.

- (a) Post confidential, personal or sensitive information about Gold Coast H.O.G. or GC H.O.G. Connections;
- (b) Make comments or statements that attack or threaten, demean, disparage, or insult another person based on their age, gender, nationality, race or sexual orientation or preference in any online forum;
- (c) Make any disparaging comments about the Gold Coast H.O.G. fellow Club Members, vendors or competitors;
- (d) Take any action on Social Media which has, or could potentially cause, a risk to the health or safety of Club Members, or third parties affiliated with Gold Coast H.O.G. including, but not limited to, any conduct which may be classified as bullying, sexual harassment, discrimination or vilification;
- (e) Imply authorisation to speak as a representative of Gold Coast H.O.G. nor give the impression that views the Club Member expresses are those of the Gold Coast H.O.G.;
- (f) Commit Gold Coast H.O.G. to any action unless they have authority to do so;
- (g) Use any H.O.G. logos or branding; or
- (h) Use any trademarks or logos belonging to a third party without their permission.
