The following is a non-exhaustive list of prohibited conduct in relation to Social Media and individual behaviour. This behaviour may be considered inappropriate by the Gold Coast H.O.G. and constitute grounds for exclusion from the chapter.

- (a) Post or repeat confidential, personal or sensitive information about Gold Coast H.O.G. or GC H.O.G. Connections;
- (b) Make comments or statements that attack or threaten, demean, disparage, or insult another person based on their age, gender, nationality, race or sexual orientation or preference in any online forum;
- (c) Make any disparaging comments about the Gold Coast H.O.G. fellow Chapter Members, vendors or competitors;
- (d) Take any action on Social Media or in person which has, or could potentially cause, a risk to the health or safety of Chapter Members, or third parties affiliated with Gold Coast H.O.G. including, but not limited to, any conduct which may be classified as bullying, sexual harassment, discrimination or vilification;
- (e) Imply authorisation to speak as a representative of Gold Coast H.O.G. nor give the impression that views the Chapter Member expresses are those of the Gold Coast H.O.G.;
- (f) Commit Gold Coast H.O.G. to any action unless they have authority to do so;
- (g) Use any H.O.G. logos or branding; or
- (h) Use any trademarks or logos belonging to a third party without their permission.
